

## FACTS WHAT DOES CETERA ADVISOR NETWORKS DO WITH YOUR PERSONAL INFORMATION?

| Why?  | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.          |

| What? | <ul> <li>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</li> <li>social security number and birth date</li> <li>income, assets, net worth and investment experience</li> <li>account balances and transaction history</li> </ul>   |
| How?  | All financial companies need to share customers' personal information to run their everyday business.<br>In the section below, we list the reasons financial companies can share their customers' personal<br>information; the reasons Cetera Advisor Networks chooses to share; and whether you can limit this<br>sharing. |

These measures include computer safeguards and secured files and buildings.</li> <li>In addition to physical and electronic safeguards, we have implemented security standards and procedures to protect your information, including employee training, limited employee access and the use of confidentiality agreements.</li> </ul> |
| How does Cetera Advisor<br>Networks collect my<br>personal information?                  | <ul> <li>We collect your personal information, for example, when you:</li> <li>open an account or deposit money</li> <li>direct us to buy or sell securities</li> <li>seek advice about your investments or enter into an investment advisory contract</li> <li>We also collect your personal information from other companies.</li> </ul>   |
| Why can't I limit all sharing?   | <ul> <li>Federal law gives you the right to limit only:</li> <li>sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</li> </ul>                               |
| What happens when I limit<br>sharing for an account I hold<br>jointly with someone else? | Your choices will apply to everyone on your account.   |
| Definitions  |  |
| Affiliates   | <ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Our affiliates include companies with a Cetera name; and financial companies such as First Allied Holdings companies.</li> </ul>   |
| Nonaffiliates  | Companies not related by common ownership or control. They can be financial and nonfinancial companies.<br>• Our nonaffiliate partners include categories of companies such as financial institutions.   |
| Joint Marketing<br>Other Important Informatior   | <ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners include categories of companies such as financial institutions.</li> </ul>   |

## Other Important Information

- Accounts with a California, Vermont, Massachusetts, or North Dakota mailing address are automatically treated as if they have limited the sharing as described on page 1.
- California residents: We will not share your personal information with a financial company for joint marketing purposes except as required or permitted by law.
- Vermont residents: For joint marketing with other financial companies, we will disclose only your name, contact information, and information about your transactions, unless otherwise required or permitted by law.
- Nevada residents: Pursuant to Nevada law, you may request to be placed on our internal "Do Not Call" list at any time by calling 844-337-2215 or emailing us at donotcall@cetera.com.
